As a result of the pandemic, after falling for several years, the numbers of people living in poverty increased in every region of the world. And as for the climate, the IPCC announced that, in order to restrict global climate warming to +1.5°C, the reduction in GHG emissions needs to be immediate and massive. Finally, the consequences of the war in Ukraine are currently exacerbating tensions on the energy and agricultural materials markets, further intensifying poverty and inequalities.



A political and security crisis situation is already a sad reality in three countries where Geres has been operating for a long time: Myanmar, Mali and Afghanistan. Here we would like first of all to pay homage to our teams in those countries, responsible, committed teams who coped in 2021 and remain at the service of communities who, despite these rough times, continue to move forward with courage, commanding our admiration.

So of course, in the circumstances, Climate Solidarity is an ever more pressing need. Between the social floor and ecological ceiling, we must take the road towards shared frugality and prosperity, "a good life for all within the planetary boundaries" (IPCC). So that everyone may live with dignity and we, collectively, can limit climate change and avoid wars for access to resources.

In France, Geres has shared in the discussions of several national civil society networks on the need to promote positive frugality, engaging for those who put it into practice, fair and inclusive in France and internationally. Because consuming less, consuming better and limiting our dependency means allowing others to access better living conditions.

Frugality means thinking of needs and solutions at territorial level and in partnership with residents, civil society organizations and private and public stakeholders. What this means in practice at Geres is: promoting low-energy housing and public buildings in Asia and Africa, launching energy and climate information services (SIEC) for citizens in the Maghreb, or supporting farmers in the Sud Provence-Alpes-Côte-d'Azur Region as they strive to reduce their energy consumption. As the third pillar of the energy transition, along with efficiency and renewable energy, frugality comes into play everywhere. Because thinking about frugality also means optimizing efforts on efficiency and access to renewable energy.

In the fight against household energy poverty for instance, Geres systematically combines technical efficiency solutions and raising awareness of low-energy uses: this combined action ensures a doubly positive effect for the climate and family budgets. Frugality also means access to electricity via community-based supply of renewable energy, produced locally and distributed via mini grids, as in the case of the Green Business Zones developed by Geres in West Africa.

But Geres will not take the road to frugality on its own. We want to share our values, our cause. In 2021, despite the lockdowns, mobilization of companies and citizens for Climate Solidarity was stepped up in our Sud Provence-Alpes-Côte-d'Azur region, where for example the first #TuGeres operation took place.

In its 2021 report, the IPCC also told us that, if we achieve carbon neutrality, warming should stop. So we are remaining optimistic and ambitious in 2022. A big thank you to all Geres teams for their commitment. A big vote of thanks to all of you, dear partners, foundations and businesses, donors, volunteers and residents, for your support and trust.

As a field operator, the NGO encourages the development and rollout of innovative, local solutions.

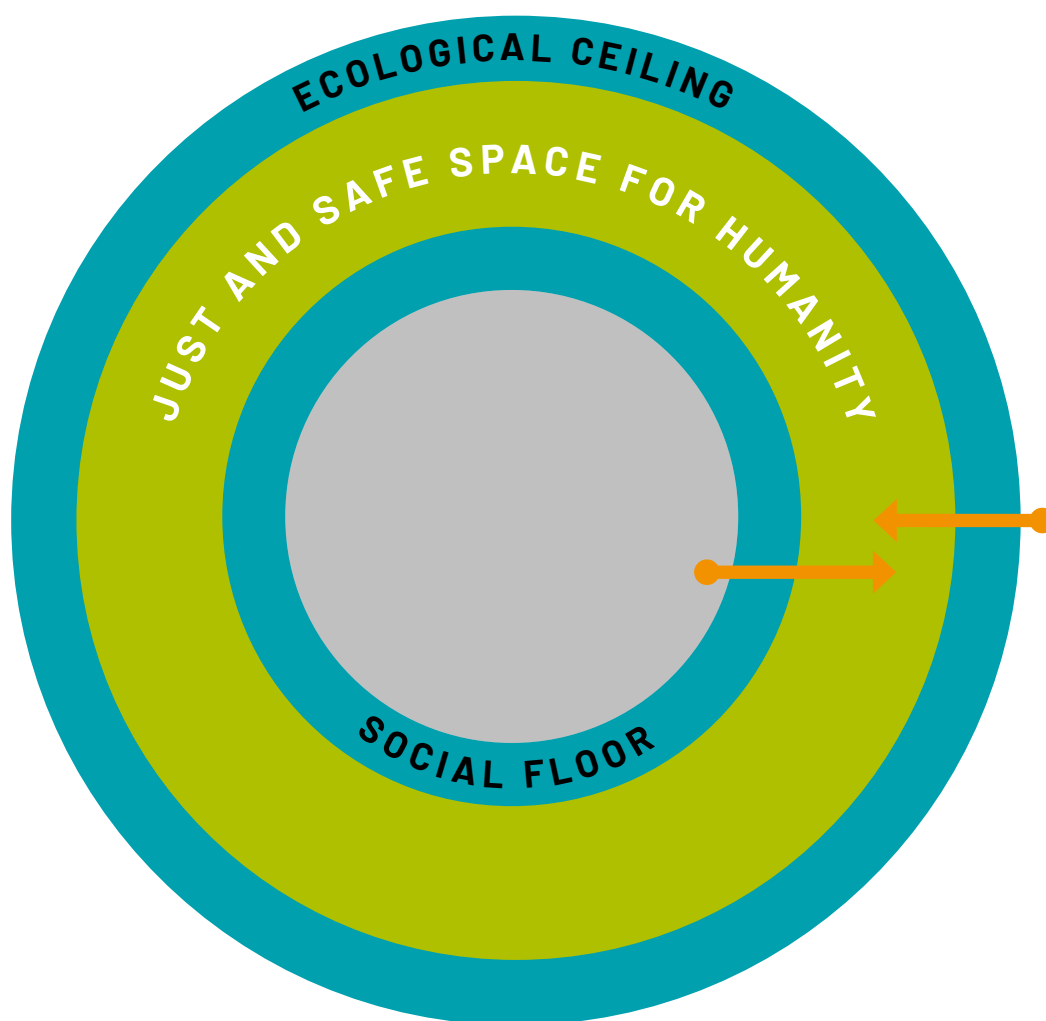

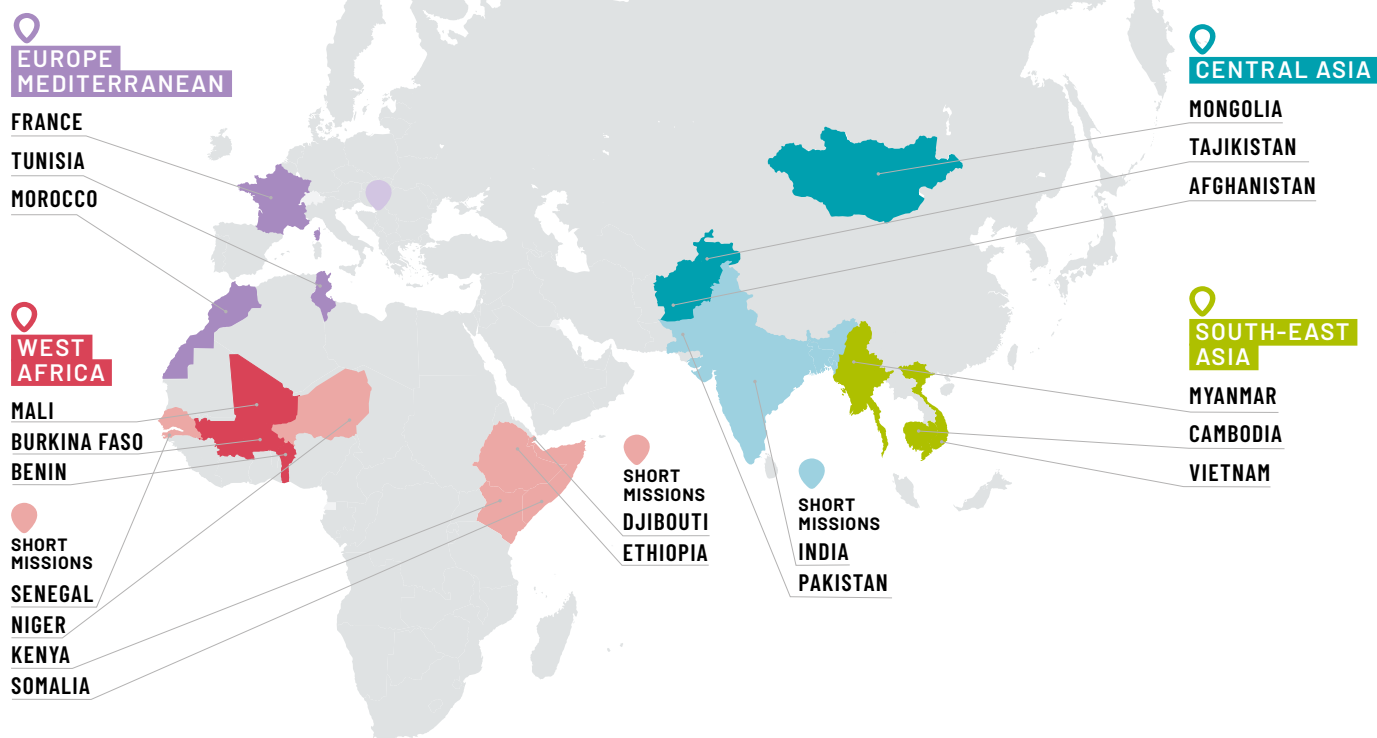

HIGHLIGHTS 2021



In Marseille, in partnership with the association *Eurasia Net*, Geres launched #TuGères, the 1st programme dedicated to Climate Solidarity training for young people. Objective: bring about changes in practices and raise awareness as widely as possible on social media.



In Myanmar, energy kits were sold during the major Pagoda Festival in Thazi by 9 Burmese women trained by Geres on sustainable rural entrepreneurship.



In October, Geres representatives took part in a round table focusing on the private sector's net zero targets, jointly organized by Carbone4 and ADEME in the France Pavilion at COP26 in Glasgow.



On 2 December 2021, to mark its 45th anniversary, Geres organized a multi-stakeholder event on the theme of the energy transition. Objective: take stock of current activities and explore future avenues.



Geres and its local partners are paving the way for change in **Tajikistan** by launching a series of activities to help young people make their voices heard and take action on climate change.

Social energy on the move with Green Biz Africa

Geres has joined forces with Malian entrepreneurs JAD and SAER GROUP* to set up the social enterprise Green Biz Africa (GBA). Its ambition? Ensure the continuity of the Green Business Areas and confirm their leverage effect on rural economic development. There was no local operator able to offer such services.

The twofold, political and health, crisis experienced by Mali in 2020 and 2021 led to revision of the initial plans. In early 2021, the business plan and financial projections were updated to take account of the impact of the health crisis on the areas where the Green Business Areas are located and on the project stakeholders. The latter were able to clarify the extent of their investment capacity and finalize the shareholders' agreement and articles of association of GBA enterprise, particularly in respect of governance, ensuring fulfilment of the social mission of Green Biz Africa. A director was recruited in the fourth quarter of 2021.

2022 I see the formal establishment of Green Biz Africa, with management of the six first Green Business Areas spread between Geres in Mali, the municipalities and GBA. Geres will hold two of the six seats on the Board of Directors of GBA to monitor and take part in the governance of the social enterprise. It will also chair the social and environmental performance committee to assist the enterprise with its social mission. A dedicated team is being recruited to enable GBA enterprise to carry out all the tasks entrusted to it, from management of the Green Business Areas through to installation of solar solutions for isolated households.

Working with stakeholders on the energy transition in Morocco and Myanmar



Apart from the issue of deforestation, the use of biomass as an energy source often causes respiratory illnesses related to inhalation of noxious smoke given off during burning. To combat these two problems, Geres is supporting people in Morocco and Myanmar, with the aid of local stakeholders, to move towards an energy transition based on gas and electricity.

Access to cooking with gas or electricity depends on meeting several conditions relating not only to the energy delivery network but also to the cooking equipment itself. While the cost of use is often competitive with biomass energy, especially in urban areas, the purchase price of the appliances is still a constraint. A wood stove, when not self-built, only costs a few euros (€3 - €8 depending on the technology and country concerned), whereas at least €40 must be spent to acquire electrical

or gas appliances. For many people, that is a significant amount, hard to raise in one go at the time of purchase. In Myanmar, Geres is working to facilitate access to these technologies, relying on Ah Lin Tan, a network of women distributors of efficient, high-quality domestic appliances. In Morocco, Geres is supporting the sector of oven producers and distributors to roll out high-quality ovens and gas cookers, produced locally and adapted to the needs of Moroccan households and bakeries.

In 2022, in South-East Asia, Geres teams will be working to extend the Ah Lin Tan network to Myanmar and replicate the model tried and tested in Cambodia.


In West Africa, the NGO is starting the Biomass Energy Sahel project, with its partners Hystra and Entrepreneurs du Monde, covering Burkina Faso, Mali and Niger. One component is aimed at strengthening the distribution chains for gas cooking kits.

Bioclimatic greenhouses for sustainable agriculture

The current situation of climate change and energy costs means that the farming sector, which is seriously affected, must take account of these new constraints, by controlling energy consumption, reducing greenhouse gas emissions and putting production on a more secure footing.

Bioclimatic greenhouses represent a low-energy production tool appropriate for small and medium-sized farms in southern France.

Since 2012, the Geres Mongolia teams have been striving to democratize the use of bioclimatic greenhouses. Rolling these out, in an arid country where the growing season lasts less than 120 days but where the sun shines on 260 days of the year, has helped vulnerable communities to boost their food security. Climate disruption, desertification and overgrazing, coupled with increasingly violent meteorological episodes, are posing ever greater threats to livestock, which used to be the main source of subsistence for rural communities. In fact, by adopting bioclimatic greenhouses, farmers have been able to double the number of growing months from four to eight. Now, Geres and its partners are promoting adoption of these greenhouses in the Sud Provence-Alpes-Côte-d'Azur region of France. Their ambition? To support farmers and preserve the environment. The rollout of this sustainable agricultural tool involves making operators in the field more aware of its advantages and educating farmers and would-be farmers.

Take the example of Lolita, a former VSI volunteer with Geres Mongolia, who decided to become a market gardener on her return to the Hautes-Alpes. In the "blue sky country", she had seen the advantages of the technology, which Geres is now planning to share with farmers in southern France.

In 2021, Geres also organized two training sessions. The first was aimed at agricultural advisers and the other at teachers from the Carpentras farm school. Following the launch of a call for expressions of interest, eleven project developers (farmers, training institutions, associations or local authorities), including Lolita, received support. Five new bioclimatic greenhouses will be established in 2022.

A second training session for agricultural advisers will be held in Aubagne. Five visits to bioclimatic greenhouses are also scheduled. Geres will finalize the service package, as well as get in touch with various potential funders (public authorities, banks, etc.).

Renewable energy catalyst in the Sud Provence-Alpes-Côte-d'Azur Region

Under its National Low Carbon Strategy, France has committed to achieving carbon neutrality by 2050. Promotion of methanation is one of the ways it plans to do this. With a mandate from the Sud Provence-Alpes-Côte-d'Azur region, Geres is providing the territory with support in the production and use of biogas.

Aware of the importance and urgency of speeding up the energy transition, Geres continued its efforts in 2021 to develop methanation in the Sud Provence-Alpes-Côte-d'Azur Region. After co-founding the Métha'Synergie* consortium in 2018, which brought together public and private operators committed to the promotion, support and development of methanation, Geres was therefore keen to structure its governance.

A strategy committee, composed of the stakeholders in Métha'Synergie, now shares project monitoring duties and guides the group's priority work. At the same time, the consultative committee, bringing together regional stakeholders in the sector, puts out technical and regulatory information and regional news,

seeking to develop inter-stakeholder skills and local synergies.

The operation of the consortium will be further structured through regular discussions on strategic issues; the establishment of a working group on communications and acceptability aimed at ensuring greater ownership of projects; and the drafting of a governance charter. New players (Water Agency, local authorities, State services, CSOs, technical institutes, etc.) will be gradually brought into the two committees with a view to federating stakeholders in the region and continuing the upskilling of the sector.

In both Morocco and Cambodia, an inclusive approach forms the primary basis of Geres work with industrialists to improve their energy performance. The objectives? To help these local stakeholders reduce their greenhouse gas-emitting consumption of fossil fuels while enabling them to remain competitive.

With the FaranEco (faran is Arabic for oven) programme in Morocco, Geres is working to develop a local supply chain for domestic and professional high energy performance (HPE) ovens using 30–50% less gas. In 2018, in partnership with three industrialists in the sector, Geres launched the “FaranEco” Label, a guarantee of energy efficiency and safety. In 2021, with the design of «green» financial packages developed by three new partners in Moroccan micro-finance, Geres confirmed its wish to co-build sustainable solutions on an increasingly inclusive basis. In this connection, the micro-credit agents in charge of marketing the packages received training (technical characteristics, sales pitch, etc.) and tools to promote the eco-label ovens.

At the same time, in Cambodia, our teams in the Switch Garment Project assisted 35 textile factories with their first steps towards

energy efficiency. More than 60 interviews were conducted to identify training needs. Our seminars, necessarily held online due to Covid19 attracted more than 100 participants. In addition, Geres and the local administration trained and assisted forest communities with regard to silviculture, sustainable planning and management and the development of activities to generate supplementary income in the protected areas. The final aim is to involve the communities responsible for managing the forest in sustainable fuel supply chains and support the energy efficiency of the country's textile factories.

In 2021, in spite of the serious health crisis in the Maghreb, public and private stakeholders in Tunisia and the Tanger-Tétouan-Al Hoceima and Souss-Massa regions in Morocco joined forces to develop Energy-Climate Information Services (ECIS) in their territories.

In Morocco, the recently established Energy Information Centre in Tata reached out to more than 2000 people and conducted a survey of 400 households to establish the population's Energy-Climate knowledge, attitudes and practices and adapt its efforts to align more closely with their needs.

The same survey was conducted in Sousse in Tunisia with municipal staff and councillors as part of an awareness campaign run by two local associations on thermal comfort and managing energy use in buildings. The operation helped to develop activities for the future Energy Information Centre promoted by Sousse council and the National Energy Management Agency.

In the Maghreb in 2022, Geres will continue to support the establishment of awareness and support

mechanisms for the general public on energy management and the development of renewable energies. Giving priority to boosting the initiatives and skills of civil society, Geres nevertheless favours institutionalization of the ECIS by involving the territorial authorities and State agencies. To encourage sharing of experience and co-building of tools, an ECIS meeting for technicians, associations and professionals from six territories in Morocco and three in Tunisia is planned for March 2022 in Oujda. Geres is also continuing to facilitate a Mediterranean working group on expensive electricity bills.



Energy and climate transition for sustainable agriculture

Agriculture in the Sud Provence-Alpes-Côte-d'Azur Region, known for its wide diversity of crops and livestock, plays a leading role in organic farming at national level but is seeing a drop in the number of farms and depends heavily on fossil fuels. It is particularly hard hit by the effects of climate change: drought, desertification of soils, flooding, etc. Since 2010, the aim of IRAEE, the network of professional agricultural players co-ordinated by Geres, has been to assist farmers with their energy and climate transition.

IRAEE members are farmer support organizations, agricultural education institutes and experts in energy and climate issues: Bio de Provence-Alpes-Côte d'Azur, Regional Chamber of Agriculture, Regional Livestock Organization, Filière Cheval Sud, CRIPT PACA, Carpentras Farm School, Solagro and Geres. In 2021, new pilot initiatives were launched on energy and climate issues related to the circular economy: using shredded plant waste as biomass energy, studying the potential of low-carbon labels, carbon storage in the soils, returnable glass containers and so on. In addition,

IRAEE supports changes in practice, especially through training of agricultural advisers on the energy transition and dedicated teaching courses within agricultural education. Finally, the "Jediagnosticmaferme" (I diagnose my farm in french) website helps to disseminate tools such as guides and technical datasheets, together with an online energy self-diagnosis tool each farmer can use to identify the priority means of action on his or her farm.

As a unique collective in France, due as much to its representativeness of the farming world as to its cross-cutting focus and mode of governance, IRAEE is building its organization with a view to gaining the status of an independent association and becoming the go-to source of information in the Sud Provence-Alpes-Côte-d'Azur Region. This greater visibility will help to reinforce the impact of its work with stakeholders in the agricultural sector.



Towards rational management of forest resources

In the Collines département of Benin, where the forest areas are seriously degraded, Geres is working to develop local value chains based on biomass energy. Objective: to reduce pressure on forest resources and improve the livelihoods of local communities.

In the Collines, the forest basin presently supplies urban areas with charcoal.

What are the impacts of this overexploitation?

C.L – In Benin and especially the predominantly rural Collines département, wood and charcoal are traditionally used by households as the main fuels for energy production. Around 2668 tonnes of charcoal are produced there every year on a largely uncontrolled basis. Faced with a growing population looking for ways to survive, the forests are suffering extreme pressure.

Are there any possible alternatives?

C.L – Despite the search for alternatives, traditional fuels cannot be out-competed by other types of fuels in the short term, for economic, social or cultural reasons. As a result, they represent the major sources of energy for most households in Benin. Traditional, uncontrolled and inefficient charcoal production practices contribute to degradation of forest areas without creating worthwhile jobs.

How can people's energy needs be met while still preserving and reconstituting forest cover in the long term?

C.L – To begin with, the priority aim of our work is to improve the efficiency of charcoal production techniques and practices and develop formal, sustainable production chains. These activities are consistent with voluntarist strategies and policies in favour of protection and rational management of forest resources.

Which local stakeholders are involved?

C.L – Two territorial authorities are taking part: the Groupement intercommunal des collines (GIC), which co-ordinates the activities of the 6 municipalities in the département, and the Moyen Ouémé forest community (Coformo), which helps the municipalities to organize the wood energy supply chain. Geres role is to foster dialogue between the various public, private and voluntary sector stakeholders and support them in putting together and implementing a biomass energy strategy in response to the need to protect diversity and combat climate change. This strategy has a twofold focus:

FOCUS A: preservation and sustainable management of the territory's forest resources to ensure benefits in terms of climate, biodiversity and ecosystem services.

FOCUS B: adding value to these resources by establishing formal local energy supply chains (wood, charcoal and biofuels) to meet needs while creating sustainable jobs in the territory.

Geres establishes itself as driver of youth engagement

We at Geres chose this year to make young people the “common thread” of mobilization, not only by developing programmes and activities designed to help them engage in their turn but also by encouraging adults to listen more carefully, pass on knowledge and support young people in the challenges they face.

There's no doubt, some young people are keen to get involved, take action, but sometimes lack the means or simply the approval of their peers they need to take the plunge, without making any mistakes. With #TuGères - the first “pilot” class of which was launched this year - we were able to support 13 young people from Marseille with their initiatives, helping them to make their ideas more concrete and impactful. Training on the sustainable development goals, information on climate solidarity issues and help to firm up their projects, plus media exposure: a total of 7 serious projects have been launched or are in the process of finalization.

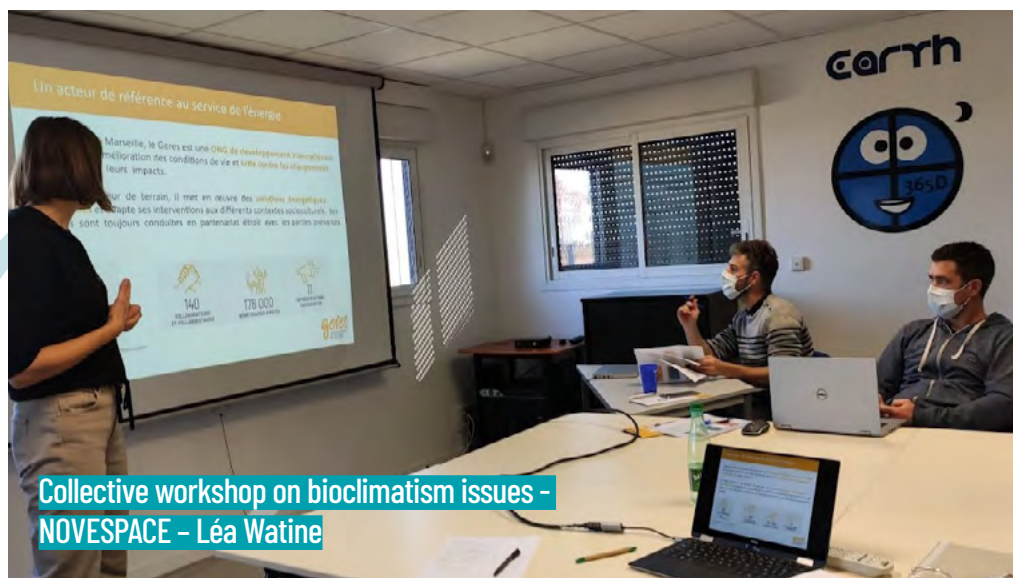
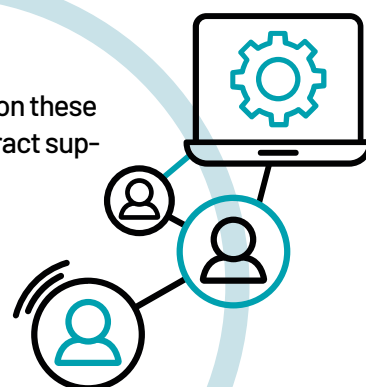

Geres, heading up Earth Day France

As of 2022, Earth Day is being sponsored and driven in France by Geres.

A major environmental event, Earth Day has been celebrated around the world every year since 1970 on 22 April. That day sees millions of activities undertaken to raise awareness and encourage citizens, associations, institutions and companies to engage with the environment. Geres role is to identify, consolidate, co-ordinate and promote these various activities with the aim of reducing environmental impact. Earth Day 2022 shines the spotlight on "eco-anxiety", a state of profound distress caused by environmental changes seen as irreversible. Citizens are encouraged to ease their environmental concerns by rallying around a series of collective activities in favour of the planet, because action is considered to be a genuine remedy against symptoms of eco-anxiety (stress, vertigo, insomnia, etc.) One more step in Geres commitment to a fair, ambitious, inclusive energy transition and efforts to mobilize French citizens around Climate Solidarity.



Something new in the East

IN TAJIKISTAN, Geres is continuing its efforts to improve rural communities' living conditions and enable them to become more resilient to climate change. The idea is to help them understand that the adoption of new sustainable practices in both the agricultural and construction sectors will allow them to live better while preserving their environment. Our work in this project consists of placing energy at the service of agriculture (installation of passive solar greenhouses, access to water and so on) and promoting energy-efficient construction techniques.



MYANMAR: TOWARDS DECENT HOUSING

In 2021, Geres and GRET conducted a study, with support from the Abbé Pierre Foundation, on the housing situation in Chin State in Myanmar. The findings of that study confirmed needs and a pilot project will start in 2022 for an initial period of two years. It will rely on local dynamic processes to implement innovative technical solutions.

Objectives: improve energy use and sanitation in the homes of the most vulnerable households and start a transition towards sustainable housing through technical and economic reinforcement of the construction sector and dissemination of improved self-build practices.

Expected results: a range of flexible construction solutions developed and improvement works facilitated: waterproofing and insulation of walls, roofs and floors; heating appliances; improved latrines; and grey water disposal.

Artisans and vulnerable households committed to implementing these solutions will benefit from training and opportunities for paid jobs which will be particularly welcome in view of the battering the country's economy has taken since the coup d'état in February 2021.

Action on energy frugality

Geres is a partner in the «Alternative Energy and Renewable Resources for Public and Residential Buildings in Abasan Al-Kabira - SUNBUILDING» project run by the Palestinian municipality of Abasan Al Kabira under a European programme. This project aims to develop the use of renewable energy in public and residential buildings, while promoting energy-saving behaviour.

In March, a meeting was held between the City of Marseille (one of the cities responding to the call for expressions of interest in joining the European mission to achieve 100 Climate-Neutral Cities by 2030), Geres and a delegation from the Palestinian municipality of Abasan Al Kabira. **The aim:** to promote contacts and exchanges between stakeholders in the energy transition.



REDUCING WOOD ENERGY CONSUMPTION

The Wood Energy Sahel project aims to improve access to cooking energy for people in the main urban centres of Burkina Faso, Mali and Niger. Funded by the French Development Agency-AFD/ French Global Environment Facility-FFEM, it will run for four years and be implemented in partnership with Hystra and Entrepreneurs du Monde. The project will help to slow down forest degradation on the outskirts of Ouagadougou, Bamako and Niamey and build the capacity of private operators in the sector and institutional structures at various levels.

Measuring Climate Solidarity

With a view to both quality and effectiveness as well as accountability and transparency, Geres was keen to develop aggregatable indicators.

These figures* reflect Geres different operational areas and enable it to measure the economic, social and environmental impacts of its work, in connection with the association's mission.

Capacity-building at the heart of the inclusive approach

In 2021, Geres consolidated the definition of its inclusive approach: making it easier for everyone to participate and mobilize for a fair, ambitious energy transition and guaranteeing access to essential energy services, including for the most vulnerable.



Adopting an inclusive approach means teams must take ownership of the gender approach, so they need to be made more aware of gender inequalities and receive professional training. With six other NGOs, Geres put together Planète Genre [Gender Planet], a card game illustrating the climate conditions of seven families around the world.

Its objective? To show that climate impacts differ according to circumstances, as well as to underline the fact that not only are people affected differently depending on their gender and living conditions but also that men and women, young and not so young can be the vectors of solutions, particularly energy solutions!

Garmaa Lkhagva, a vegetable grower in Arkhangai province, is among the change agents supported by Geres in Mongolia. She is one of the 17 women trained by the Ulan Bator agricultural university to provide coaching on vegetable growing. The head of a single-parent family, she is employed at a local service station where she often works nights. It's now five years since Garmaa began growing vegetables in her bioclimatic greenhouse. She feeds her family with her produce, keeps some for winter and sells the surplus. The revenue from her crops has enabled her to fund the studies of her two children and she is now saving for her plan to purchase a flat. Through the ImpACT project, Garmaa was able to link up with the local authorities who identified her, at the autumn show and sale, as a resource person on vegetable growing. She was then promoted

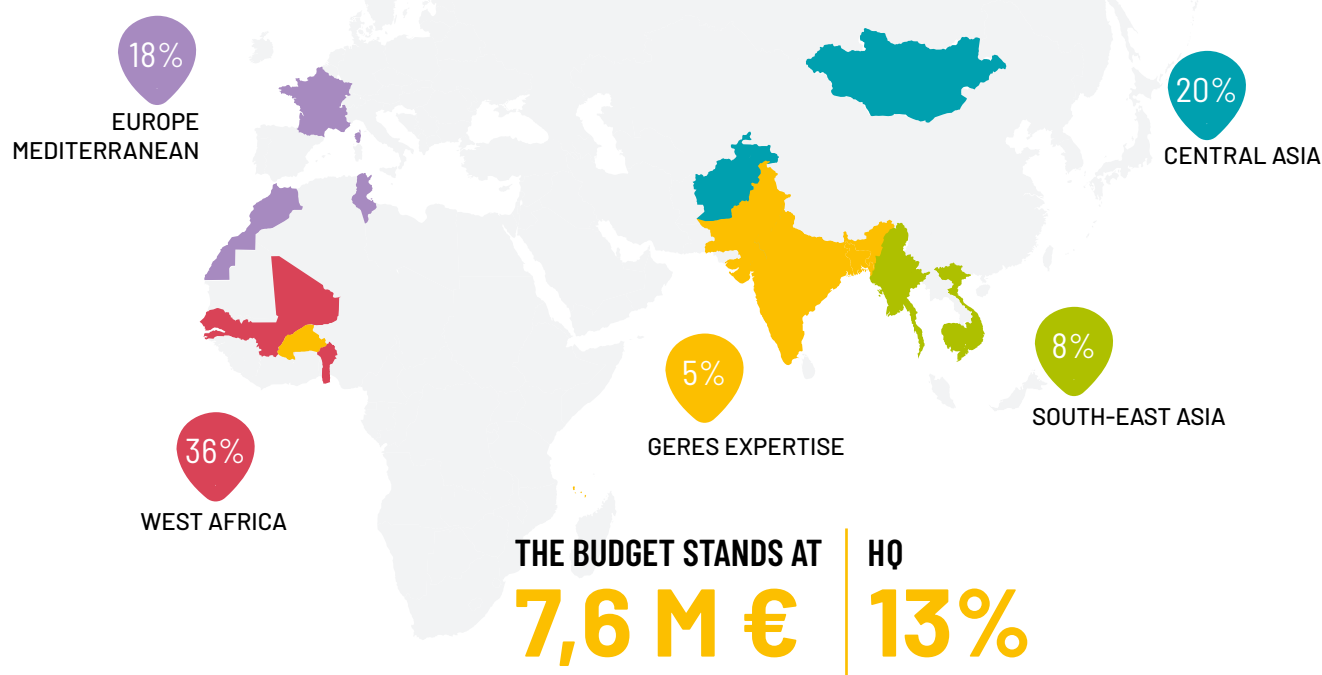
to the position of "representative of the female gardeners" on the Local Women's Council and now plays the role of mentor for her peers, under the co-ordination of the Provincial Women's Council.

Anne Brukhanoff, *leader of ECODEV programme – the Geres Entrepreneurship Support programme, has had training on gender-based monitoring and evaluation.*

|| The issues involved in gender relations are closely connected with energy access. Taking account of the gender approach means recognizing that gendered differentiation of roles and powers leads to discrimination in access to education, health and resources".

The budget stands at €7.6 M. It is 5% higher than in 2020 (+€343,000). West Africa remains Geres foremost area of operation (36%) despite a small drop of €23,000 (-1%). Central Asia, with an increase of €241,000 (+21%), returns to second position. It is followed by the "Europe-Mediterranean" (18%) and South-East Asia (8%) regions, recording a net increase (+31%), and the cross-cutting expertise unit (5%), which continues to support our country projects.

The bottom line

Geres is in surplus for its 2021 financial year.

The bottom line, €36,000, reflects a drop of €74,000 (-67%) compared with 2020, despite the increase in activity and reduction in operating and fundraising costs (-€86,000, -8%). This decrease is mainly due to project co-funding risks, for which provision has been set aside, and the reduction in the surplus generated by carbon finance: €1000 as against €20,000 in 2020.

Appropriations/recovery of provisions had a negative impact, -€283,000, on Geres bottom line, as against +€18,000 in 2020.

On the balance sheet, the amount of provisions covering all identified risks increased sharply to €788,000, compared with €464,000 a year earlier.

Prospects

Activity relating to the association's purpose increased slightly in 2021, after the drop seen in 2020. This increase is nevertheless lower than the budgeted figure. The security and political situation in Mali, Afghanistan and Myanmar, along with the health situation relating to Covid19, particularly in South-East Asia and Central Asia, slowed the pace of implementation of activities or deferred signature of agreements.

We are planning an increase in our operating budget for 2022, as well as implementation of our strategy of citizen mobilization around Climate Solidarity issues, which was delayed in 2021 due to the health situation in France.

Financial transparency

Operating and fundraising costs accounted for 12.3% of the total budget as against 14.1% in 2020 (-€86,000, -8%). They have therefore fallen for the second consecutive year. The economic situation is partly responsible for this decrease, as travel, training and some outside events were restricted in 2021. An increase in our operating costs is therefore planned for 2022 in view of the expected full implementation of our mobilization strategy.

Geres accounts were signed off by the Board of Directors on 13 June 2022 and certified by the auditors Llinas Audit. certifiés par le commissaire aux comptes Llinas Audit.



The IDEAS label confirms the quality of our practices in terms of governance, financial management and monitoring the effectiveness of our activities. It is awarded by an independent committee.

enables Geres to incur expenses while receiving the necessary advance payments from donors, optimizing its cash flow.

The latter continued to increase, from €4.2 million to €7.9 million, in 2021 (+ 3.7 million, +89%).

The loans contracted in 2015 were cleared on maturity in 2021. Thanks to the surplus generated in 2021, **own funds continued to increase**, reaching €1,401,546. They accounted for 18% of the budget for 2021, representing 2.3 months' work.

Implementing projects in deteriorating political and security situations.

Three of the countries where Geres works experienced major political events in 2021, affecting our teams, the implementation of our projects and the overall volume of our budget.

In February, a coup d'état in Myanmar put a stop to our activities. We reorganized the teams, particularly by nationalizing our country representation staff, reinforced our security processes and carried on remote monitoring in close liaison with the local team.

Mali was next to experience a coup d'état, in May, resulting amongst other things in sanctions imposed by the Economic Community of West African States, which slowed down some investments in equipment. In Afghanistan, the takeover of power by the Taliban in August 2021 led the donor to suspend activities for several months, although salaries and other operating costs remained eligible for funding. These events have an impact on communities and Geres national teams. Despite the difficulties related to security aspects, remittance of funds, more complicated procedural controls and slower paces of implementation, Geres will continue to work closely with beneficiaries and implement projects. If conditions permit, we even plan to develop them further in 2022 and 2023, particularly in Mali and Myanmar.

Actual uses increased by 7% between 2020 and 2021, rising to €7,206,000.

Activities in West Africa, still Geres foremost area of operation (€2,559,000) remained stable (-0.9%). The project funded by Swiss Co-operation, aimed at developing six "Green Business Zones" (ZAE) and establishing a social enterprise - "Green Biz Africa" (GBA) - continued. GBA was registered in March 2022. An agreement was signed at the end of 2021 with the French Development Agency (AFD) for €6.5 million over four years, in order to continue replication of the system (+6 ZAE to come).

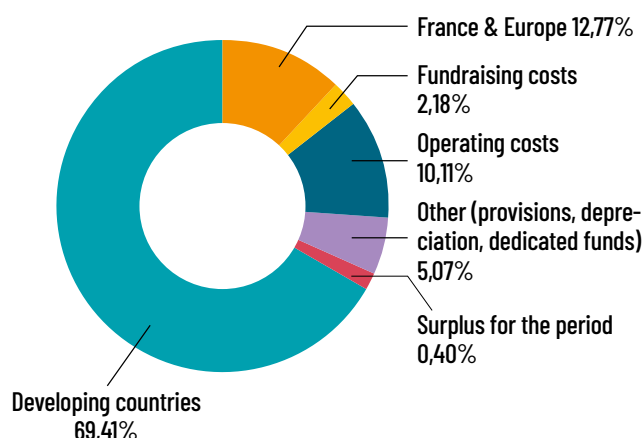
Central Asia (+21%) is Geres second most important area of operation, where two programmes funded by the EU, AFD and the Abbé Pierre Foundation are ongoing, aimed at developing innovative, adapted housing energy solutions. The project begun at the end of 2020 in Kabul, Afghanistan, with funding from GIZ (Deutsche Gesellschaft für Internationale Zusammenarbeit) was suspended for several months after the Taliban took power on 15 August 2021. It was able to resume and a second agreement was signed with GIZ. In Tajikistan, a new EU-funded project started work on training young people, future craft masons, to take up energy efficiency solutions.

The Europe-Mediterranean region saw an increase in activity (+€130,000, +11%), rising to €1,321,000: France (+€85,000, +10%) and "Morocco-Tunisia" (+€44,000, +15%). The SIEC project on developing Local Energy and Climate Information Services, which began in those two countries in 2020, carried on despite difficulties related to Covid19 and political upheaval (in Tunisia). Phase 3 of our ECODEV (Energy Access & Economic Development) programme began in Morocco. In France, the projects implemented in the Sud Provence-Alpes-Côte-d'Azur region were funded by ADEME and the Regional Council. In 2021, phase 2 of our "Methanation" project began, together with the last phase of the IRAEE multi-stakeholder network for the energy transition in the agricultural sector.

South-East Asia saw an increase in activity (+31%), driven by the EU-funded project on the textile industry in Cambodia. In Myanmar, phase 3 of the project funded by AFD to develop a network of women engaged in last kilometre distribution of energy-efficient appliances got under way in 2021. It is designed to ensure continuity of the operation and set up the Ah Lin Tan social enterprise.

The Expertise unit recorded a 12% increase. In particular, it continues to co-ordinate the cross-cutting components of the programme agreements signed with AFD (CEMAATERR and ECODEV agreements).

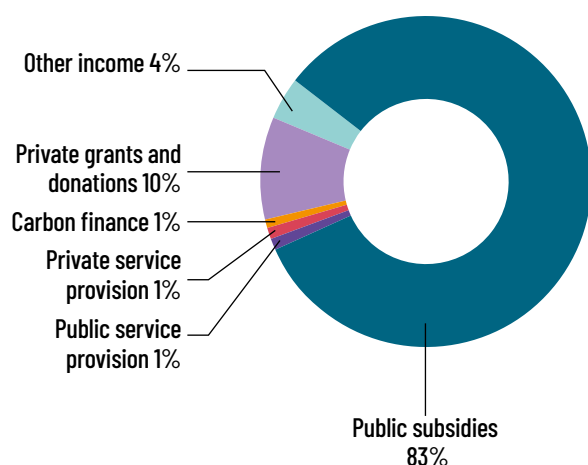

Actual operating funds amounted to €7.4 million in 2021, an increase of €399,000 (+6%) compared with 2020.

Grants accounted for 92% of actual operating funds, as against 90% in 2020, with an almost identical proportion of public grants: 83% of actual funds as against 84% a year earlier.

Sales of carbon credits fell sharply, from €305,000 in 2020 to €42,000, returning to their 2019 level. The

stock of Carbon Credits generated by "Wassa" improved stoves in Mali increased (around 20,000 tonnes as against just over 4000 at 31/12/2020), so it should be possible to increase sales in 2022.

Turnover from **service provision** is stable. As in previous years, it came mainly from three regions and services: South-East Asia, Europe Mediterranean and the Expertise unit. The latter is responsible for 56% of Geres service activity.

Individual donations generously given by the public remain low in relation to total funds (€87,000, 1% of actual funds) but have increased in relation to 2020 (+€19,000, +28%).

Other income (€377,000) increased significantly (+€120,000, +34%), despite the fall in recovery of provisions (-€231,000). This change is mainly due to variation in the stock of carbon credits in Mali and ongoing service provision (+€110,000) as well as in **other operating income** (+€176,000). Income from partnerships concluded in connection with mobilization of companies for climate solidarity rose from €56,000 to €111,000, while foreign exchange gains amounted to €81,000 as against €8000 in 2020.

Groupe Initiatives

Set up in 1993, Groupe Initiatives (GI) is a 13 member collective of professional international solidarity associations. A forum for debate and sharing of experience and practice, it helps to inform the thinking of the development community and put together public policy recommendations. Its activities and expertise are focused on three main areas: promoting relevant, efficient practices and methods; capitalizing, producing and disseminating knowledge; and advancing international solidarity practice and policy. Vice-president of the GI in 2021, Marie-Noëlle Reboulet will assume the Presidency of the GI in July 2022.



Coordination SUD

Coordination SUD co-ordinates French international solidarity NGOs, bringing together more than 130 associations engaged in emergency humanitarian action, development aid, environmental protection, defence of human rights and advocacy. In 2021 Geres has concluded 9 years as leader of the climate and development commission and development commission; a commission in which we will remain very active.
